# 16. Loss of Local Bus Service 870 from Consett – Hexham – Evidence of hardship especially for High School students.

a) Completed questionnaire at Shop, which showed a cross section of the public using this service. E-mails from parents with two or more children needing the public service to assist with school times.

b) Report from Healey PC High School pupils do use the service from at least 2 families for school, leisure and work reasons. Staff at Minsteracres Retreat Center also use the service on a daily basis.

c) Confusion over the Clerk's comments on QEHS being closed during the school day resulting in why lower & upper sixth form high school pupils need the public service arose. School ends at 2.15 on alternate Tuesdays, but school buses operate at the normal time.

d) Mrs Jewitt wished to record the hardship she and many other parishioners would experience if the service were to be reduced to one journey each day.

e) CC Horncastle reported a Working Group set up to look at rural transport. Ian Coe is leading the discussions and CH would put our concerns to the group.

f) The ADAPT Dial-a-Ride Blanchland-Hexham service on Tuesdays calls at Slaley - information will be published again in the Parish News.

This has led to confusion over which land is Forestry Commission with open access and which land belongs to Lord Allendale and private.
