Cllr S.C. Douglas and Reverend Helen Savage spoke after this meeting and they are exploring the idea of offering a parish certificate to Teenagers for involvement with different aspects of the community e.g. helping on the Showfield, helping at Ladycross Nature Reserve on a farm or something similar. This would be similar to The Prince's Trust and the codeword for this Parish Certificate will be "how can we help?" A Housing needs survey was discussed both at this point and during agenda item 18. - a) Village resurface work Sir. M.D. written a letter of complaint to Cllr P Jackson copy attached as appendix. Highways returned to the village during Thursday July 5th Monday July 9th worked on utility covers and cleaned out the village drains.
- b) Footpath No 10 to Peel Flatt 0.5 mile from the Riding Mill road over the stone style into Townfoot roadside woodland is impassable due to brambles. Someone has tied red and white tape to the tree trunks in what looks to be an attempt to stop people using the footpath. The PC is aware that the Caravan Site has recently been sold and possibly the new owner thinks that the footpath is no longer needed.
