#### 5. Matters Arising:

a) Glen Crossroads. told 11/1/21 that Mr. McCartney would consult with Mr. Murrell – CC Horncastle had no further update. Cllr PJ Cain reported resending his former Neil Snowdon correspondence with photographs to <u>highwaysprogramme@northumberland.gov.uk</u> November 2020. This resent correspondence had not been acknowledged by anyone. CC, C Horncastle to investigate.

b) School House – A lengthy discussion took place of the various different business ventures and the enforcement notices either served or pending due to the Pandemic arising from the site. The history of several goes back a considerable time and the question arises if this could be a delaying tactic to get permission through default. What is the NCC Policy? We have one piece of correspondence quoting lack of funding for a reason not to proceed with Enforcement action. CC Colin Horncastle reported that he was seen as having a personal interest in School House planning and was not therefore always included in discussions with senior officers however, it was on the agenda for the March area meeting on Tuesday. Twenty horses escaped from School House during the February week of heavy snow and found their way onto the A68 and A69, Northumbria Police were called out to at least two accidents involving the horses, where snow drifts were cited as the reason the horses were able to escape their fields.

The Judicial Review was discussed - recent email correspondence includes:
