#### 14. AOB

a) December 1<sup>st</sup> - elderly man cleaning Slaley signs and dropped cleaning paper on grass verge reported to Highways & notes editors. Highways were unable to shed any light on this person.

b) Clerk received an email on November 23<sup>rd</sup> from a concerned resident at Wooley that this portion of the parish was NOT represented on the Council. Clerk replied immediately and explained about the 2013 elections and the current allocation of councilors. A further reply was received with an explanation to the PCs request for Councillors in 2013, explaining that no personal commitment had been possible at that time. However with the change in personal circumstance the wish to join the Council to represent the Wooley area residents was reaffirmed. Clerk had explained the allocation and election process. c) Mobile Post Office no service Monday 30<sup>th</sup> p.m. because of a funeral and the vehicle into a Newcastle garage for a service. Then again no service at Slaley 8.30 a.m., on Wednesday December 2<sup>nd</sup>, because of an accident on the A1 after picking up the serviced mobile post office from the garage.

d) Flooding on the C275 (Riding Mill road) reported to Highways November 30<sup>th</sup>. Still flooded. e) Damaged Slaley Parish Council notice board after hurricane Abigail – Repairs? Cllr Bell suggested Matthew Ford. Clerk contacted Matthew by his mobile and Margaret Weatherley about her Grandson, David Stokoe, who is a joiner, for a price – as yet no replies from either person. One hinge is snapped and one torn out of the wooded frame. Clerk had the door at the meeting. Cllr Allsop volunteered to make good the stand and refit the door if it was straightforward.

f) Cllr David Short (Hexhamshire) requested a letter from the BOATs sub committee for a planning application to upgrade a bridleway on the Hexhamshire Common to a 8000m hard surfaced track for vehicles. A letter was drafted and agreed by the BOATs sub committee, circulated to the Councillors and forwarded to the planning department. Attached as appendix 2/141215. page 1116.

g) Damaged surface on the B6307 (Dilston to Linnels bank top road some quarter mile from the woodland sale board) emailed to Ray Weallans on December 12<sup>th</sup> and then reported by telephone on December 13<sup>th</sup> to NCC emergency line. The Clerk understood that work had been done on Monday 14<sup>th</sup> around lunch time. Cllr Green questioned this and thought that he had driven through the hole on Monday evening but that someone had placed a highway cone in the centre of the road.
